Cambridge Üniversitesi Matbaası tarafından basılan ve ilk sayısı Ocak 1970 de çıkan *International Journal of Middle Eastern Studies* (kısaltması *IJMES*), yani *Uluslararası Orta Dođu Çalıőmaları Dergisi*, Profesör Stanford J. Shaw'un başkanlığında bir yazı kurulu denetiminde yayım hayatına başlamıştır. Derginin ilk on cildinde hangi kuruluş tarafından çıkarıldığı belirtilmemekle birlikte, onbirinci ciltten başlayarak, *Middle Eastern Studies Association of North America*, kısa tanımıyla *MESA*'nın sorumluluđu altında çıktığı anlaşılmaktadır.

IJMES, VII. yüzyıldan çağımıza değin başta Arap ülkeleri olmak üzere İran, Türkiye, Afganistan, İsrail ve Pakistan'ı kapsamına alan geniş bir bölge ile ilgili makale ve eleştiri yazılarını basabilecek bilimsel bir dergi olarak ilgi alanını çizmiştir. ayrıca İspanya, Güney-Dođu Avrupa ve Sovyetler Birliđi'nin Orta Dođu uygarlığı etkisinde kalmış olan bölgeleri de derginin kapsamına girmektedir. Buna ek olarak Orta Dođu'da kurulmuş İslam İmparatorluklarına bađlı ya da bunların yönetimi altına girmiş ülkeler de derginin konuları arasında yer almaktadır. Tarih, siyasi bilim, ekonomi, antropoloji, psikoloji, edebiyat, folklor, karşılaştırmalı din ve ilahiyat, hukuk ve felsefe alanları çerçevesindeki çalıőmalara özel bir ilgi gösterileceđi daha derginin ilk sayısında belirtilmiştir. Bu sahadaki araştırmacılara ışık tutacağı ve yararlı olacağı inancıyla Orta Dođu arşivlerinde çalışan bilim adamlarının ilgili arşivler hakkında ve karşılaştıkları kaynaklar üzerinde hazırlayacakları rapor ve tanıtma yazılarını dergiye yayımlanmak üzere göndermeleri özellikle istenmiştir.

1970'den 1980 yılına kadar *IJMES*'in yayımcılık görevini başarıyla yürütmüş olan Los Angeles, Kaliforniya Üniversitesi Türkçe ve Yakın Dođu Tarihi profesörü Stanford J. Shaw derginin giriş yazısında, *IJMES*'in gelecekte başarı sağlayacağından ümitli olduğunu belirtmiştir. Ayrıca

yayımcı bu derginin, tüm Dünya'daki bölge araştırmacılarının ortaya koydukları Orta Doğu ile ilgili bilimsel buluşları paylaşmak için ana bir araç olacağı inancını vurgulamıştır. Hiç kuşkusuz, *IJMES*, Profesör Shaw'un bu inancını kendi yönetimindeki ilk on yıllık yayım hayatında gerçekleştirmiş, daha da ileri giderek Orta Doğu ülkelerinin hemen hepsiyle ilgili değerli bilimsel ve örnek makaleleri bünyesinde toplayarak okuyucularına beklenen hizmeti vermiştir.

Derginin uzun süre tek yayımcı tarafından yönetilmesine karşın "yazı kurulu"da dönüşümlü olarak her üç yılda bir, bazı değişik bilim adamlarının görev yaptığı gözlemlenmiştir. *IJMES*'in ilk "yazı kurulu" kendi alanlarında yetkili olan şu isimlerden oluşmuştur: W.M. Brinner, O. Grabar, C. Issawi, M. Kerr, B. Lewis, K. Salibi, R.M. Savory, R.B. Sergeant, N. Yalman. Ne varki, IV. cilt'ten başlayarak "yazı kurulu"nun yanı sıra dergiye "kitap eleştiri kurulu" da eklenmiştir. VII. cilt'ten sonra "yardımcı" ve "tanıtma" yayımcılarının da görev almasına gerek duyulduğu anlaşılmaktadır.

Yılda çıkan dörtte sayısı bir cildi oluşturan *IJMES*, yalnızca Orta Doğu'nun çeşitli yönleriyle ilgili İngilizce olarak yayım yapan diğer bilimsel dergilerin belki de en kapsamlısı ve yayım hayatını düzenli bir biçimde sürdüren bir dergi olduğuna kuşku yoktur. Bu nedenle, *IJMES*'in bu dizini Orta Doğu ile ilgilenen araştırmacı, öğretici ve okurlara yararlı olacağı düşüncesinden hareketle hazırlanmıştır. *IJMES*'in 1970-1980 yılları arasında basılmış olan I-X. ciltlerini kapsıyan bu dizin, beş bölümden oluşmuştur. Ülkemizde İngilizce bilen araştırmacıların geniş bir taban oluşturduğu varsayımıyla hiç bir makale veya kitap tanıtma yazılarının Türkçe'ye çevrilmesine gerek görülmemiştir. Kaldı ki, her yazı başlığının Türkçe'ye çevrilmesi bu dizinin bir bütün olarak dergide yayımlanmasını güçleştireceği ortadadır.

I. Bölümde makaleler, yazarlarının soyadlarına göre ABC'sel olarak derlenmiştir. Kitap tanıtma yazılarına ayrılan II. Bölümde de, aynı yol izlenerek, yazar soyadlarına göre sıralanmış olup, tanıtmayı yapan yazar parantez içinde verilmiştir. III. Bölümde derlenen makalelerde konular esas tutularak *IJMES*'in özelliği gereği öncelikle ilgili ükelere göre ayrılmış, sonra da yan başlıklar ABC'sel olarak yazılıp, altlarına ilgili olan makaleler aynı biçimde, yazarlarına göre düzenlenmiştir. Araştırmacıya kolaylık sağlayacağı gerekçesiyle birden fazla ülkeyi veya konuyu ilgilendiren makaleler, ilgili yerlere tekrar yazılmıştır. IV. Bölüm, kısa notlar ve haberleşmeye ayrılmış olup, yazarlarına göre düzenlenmiştir. Kısa olan V. Bölüm Nekroloji'ye ayrılmış, vefat eden bilim adamları soyadlarına göre yazılmış, tanıtmayı yapan yazarlar parantez içinde gösterilmiştir.
